WHAI Statement for the Rights, Safety & **Protection of 2SLGBTQ+ Communities**



Amidst the rise in local and international discrimination and violence against 2-Spirit, Lesbian, Gay, Bisexual, Trans, Queer, Non-Binary communities and those with other gender and sexual identities and expressions, WHAI acknowledges our solidarity and support for the safety and inclusion of 2SLGBTQ+ communities. Discrimination and violence against people in these communities is growing around the world. Globally, Trans Murder Monitoring, a project by TGEU (Transgender Europe), documented 327 murders of Trans and gender-diverse people in 2022, with 95% identified as Trans women or Trans-feminine people. Of those whose occupation was known, half were sex workers. Where race and ethnicity were known, 65% were racialized Trans people (1). In Canada, Amnesty International notes hate crimes against 2SLGBTQ+ communities in Nova Scotia, Quebec, Ontario (2), with more hate-based actions being continuously documented in other provinces. These global and local realities continue to grow, and solidarity for safety, respect and inclusion is critical.

WHAI is committed to working with all people who identify as 2-Spirit, Lesbian, Gay, Bisexual, Trans, Queer, Non-Binary. WHAI work fundamentally seeks to improve health outcomes related to HIV and empower community capacity to address and rectify the ongoing legacies of homophobia, transphobia as well as cis-heteronormativity.

We are committed to actively celebrating, amplifying and working alongside and in collaboration with 2-Spirit, Lesbian, Gay, Bisexual, Trans, Queer, Non-Binary communities publicly, without shame or restriction, and working actively against violent and discriminatory policy and rhetoric locally and globally. We are committed to honouring the lives lost to anti-Trans and 2SLGBTQ+ violence.
